#### PRESIDENT'S REPORT

It is my pleasure to present the 2019 Annual Report for Badminton WA. This year has been a busy and fulfilling time for the Association.

Our top state teams have achieved fantastic results and have been successful in becoming medal winners at all three of the Junior National Carnivals. The Under 15 team were silver medallists, while the Under 17 and Under 19 teams were both bronze medallists. Big congratulations to all players, coaches, parents and managers for all the hard work they have put in.



We hosted the inaugural 2019 Perth International which was the first international badminton event held in WA in excess of 20 years, with over 100 players from 9 countries. The highlight of this Badminton World Federation Future Series event included the participation of a former world number one player from Malaysia, who took the men's doubles title. Other titles were dominated by Chinese Taipei players and shared the total prize money of USD\$9,999. We also hosted the CP Maddern Trophy and Under 19 Championships in Mandurah, a beautiful region for visiting players and officials, just outside our capital city Perth.

The Board of Management has continued to review and develop new policies to strengthen governance for the Association. In addition to the existing strategic plan with the five pillars, there will be added focus on capacity building and communications for 2020. Planning will also commence soon for Strategic Plan 2021-2023, potentially a refreshed vision *For badminton to be one of the most popular sports in Western Australia*.

Board members, coordinators, committees, staff, volunteers, members, parents, coaches and officials have all been working together to ensure all events, courses and activities were delivered as smoothly as possible. The Association would not be able to function without the dedication of these people. My sincere thank you to every one of you, for the hours you put in, the volunteering you do and the support you give to our members. Badminton WA owes you huge gratitude for the commitments you show.

It is encouraging to note that our financial position has strengthened over the last year with a surplus of over \$10,000 for this very busy year, a turn around from last year's deficit. Our badminton community has worked hard together especially in the running of an international and a national event in the same year, which was unprecedented. Congratulations and a big thank you to every person who has been involved in the events, especially the life members who have been contributing their valuable time to the Association for many years.

I would like to express special thank you to our outgoing Executive Officer, Eugene Glazman and outgoing Administration Officer, Elaine Lee; for their 11 years of combined service for the Association. I wish them both the very best in their future endeavours. I would also like to extend a warm welcome to our new Executive Officer, Rick Wolters who recently joined Badminton WA.

Lastly, I would like to sincerely thank our President, Lily Buttrose, for her leadership and guidance of the Association towards the achievements and positive results this year. We look forward to the challenges and opportunities that the year 2020 will bring.

#### **EXECUTIVE OFFICER'S REPORT**

2019 was another successful year for Badminton WA and the broader badminton community in Western Australia. A highlight of the year was our successful hosting of the Perth International, showcasing the continued capability of Badminton WA to host events to the highest quality.



Badminton WA successfully hosted over 20 tournaments during the year. Our youth development program continues to be successful with a healthy increase in player numbers during the year. At grass-roots level, the Shuttle Time Wings programs continue to grow in depth and breadth, enrolling children in the 7-16 year introductory program that is being delivered through a network of ten Wings centres.

Our High Performance program has seen much success involving the High Performance squads, training camps and State teams representing WA at the National Championships for Under-15, Under-17 and Under-19 levels. Particular highlights of 2019 were the silver medal at the Australian U15 Val Nesbitt teams event; the bronze medal at the Australian Under-19 CP Maddern teams event and the bronze medal at the Australasian U17 June Bevan teams event. At the individual level Timothy Sentosa and Joanne Zheng achieved top 10 Australian rankings. Timothy was successful in winning the gold medal in singles and doubles whilst being runner up in the mixed doubles with Joanne Zheng. Joanne Zheng won a gold medal in girls doubles, and was runner up with Timothy Sentosa in mixed doubles at the Australian U15 Championships. As a result Joanne and Timothy were nominees from Badminton WA for Youth Sports Star of the Year.

2019 was a significant year for para-badminton with Lochan Cowper and Grant Manzoney participating in the men's doubles D grade at both the LiveLighter WA Open State Championships and the LiveLighter Summer Championships. The pair also did us proud in the wheelchair classification at the 2019 Australian Para Badminton Championships in Melbourne, with Grant winning the WH2 singles title and Lochan defeating the Oceania champion to win the WH1 singles title. Together they secured the WH1/WH2 doubles title.

Badminton WA enjoys great support from the corporate and government sectors and continues to be in a stable financial position. We are grateful for the invaluable assistance of the Department of Local Government Sport and Cultural Industries (DLGSC), LotteryWest, Healthway, the City of Wanneroo and the Mandurah and Peel Tourist Organisation (MAPTO). We work closely with our key stakeholders and have excellent corporate relationship with them.

Badminton WA is ready and looking forward to 2020.




#### MEMBERSHIP—PLAYERS

Membership levels have shown small but steady growth with increased Wings junior club memberships as well as more tournament players becoming annual members.



Encouraging growth in juniors continues, thanks to our Wings, Sporting Schools and inter-schools tournament programs.



Data shown as per the Membership Register at 31 December of each respective year. The latest total for the 2018/19 membership year (as at 20/03/20) is 3034 members, in addition there are 135 secondary members.

- Note 1: Final numbers at the end of each respective membership year do differ as they include registrations received between 1 January and 31 March.
- Note 2: Membership numbers don't include Sporting Schools program participants, since only a fraction of participating schools provided the respective details.
- Note 3: Membership numbers do not include Secondary club members to avoid "double count".
- Note 4: Event members include an element of "double count" due to the nature of this membership category.

#### MEMBERSHIP—CLUBS AND ASSOCIATIONS

Our four affiliated associations - Bunbury & Districts, Geraldton & Districts, Eastern Goldfields, and South Suburban - continue their affiliation status with us. This ongoing support is appreciated in light of challenges with finances, membership levels, facility access, and the recruitment and retention of volunteers.

The number of affiliated clubs has remained stable compared to last year, with several new or "renewed" clubs - both Metro and Country - affiliating with Badminton WA.

The network of Badminton WA's Wings junior clubs has stabilised at ten clubs, covering areas both north and south of the river in Perth.

Several of our incorporated clubs have commenced and/or completed important work of ensuring compliance with the new Associations Incorporation Act 2015, and we have provided them with our assistance where possible.



#### INCLUSIVITY AND PARA-BADMINTON



2019 was a challenging year for inclusivity with the resignation of Ian Bridge and difficulties with running new programs due to a lack of funds.

We were able to continue running Bad Wheels each week and, with a core group of players and new coach and structure in place for 2020, we will look to add new players to the group. There are plans to run a number of 'come and try' days in 2020 with the aim of attracting new players to the sport.

It was fantastic to see West Coast Badminton Club open their doors for wheelchair players Lochan Cowper and Grant Manzoney to join and play with and against able-bodied opponents. This gave both players valuable practice leading up to local and international tournaments.

In a first for inclusivity in Australian Badminton, Lochan and Grant participated in the men's doubles D Grade at both the LiveLighter WA Open State Championships and the LiveLighter Summer Championships. With the lack of wheelchair players in WA providing few opportunities for match practice, participation at these events was invaluable for Lochan and Grant's later participation at other local and international events.

A highlight of the year was Lochan and Grant securing a clean sweep for WA in the wheelchair classifications of the 2019 Australian Para Badminton Championships in Melbourne. Grant was untroubled in winning the WH2 singles title while Lochan put on a great display to beat the Oceania Champion and go on to win the WH1 singles title. The pair then teamed up to secure the WH1/WH2 doubles title.



The fact that three para players, Lochan, Grant and Caitlin Dransfield, all compete in mainstream tournaments shows that Badminton is truly an inclusive sport in Western Australia.



The race to the Tokyo Olympics qualification began in 2019 with the majority of international tournaments earning players ranking points toward Paralympic qualification. Caitlin Dransfield and Grant Manzoney both competed in a number of tournaments including Turkey, Dubai, Ireland, Thailand, China, Japan and the World Championships in Switzerland. Grant secured a few wins but was unable to advance out of the group stages in any of his tournaments.

After a slow start, Caitlin strung some wins together in the latter tournaments, earning several quarter-final finishes as reward for her hard work. Lochan also competed at the Thailand International where he showed great improvement and gained experience that will stand him in good stead for his on-going progression.

Grant finished the year ranked 40<sup>th</sup> on the BWF World Ranking in men's WH2 whilst Caitlin's impressive performances saw her finish the year ranked 15<sup>th</sup> on the BWF World Ranking in women's SL4 which is a great achievement.

All three players will no doubt benefit from the experiences gained against high quality opposition.

#### JUNIOR DEVELOPMENT

The Badminton WA Junior Development Program consists of several different aspects that are operated through different formats and approaches, often incorporated or alongside other participation and development initiatives.



#### **School Clubs and Training**

- \* School clubs evolve through various initiatives such as ATAR school-specific ex-curricular training, Badminton WA School Tournaments, Shuttle Time Wings Program, inter-school carnivals, and direct services from private coaches.
- \* Most school clubs / groups operate independently. Some schools directly hire the services of coaches recommended by Badminton WA.
- \* Most of these clubs are not affiliated, except for those within the Wings Program.

#### **School Tournaments**

- \* Four in term tournaments were attended by 550 players from schools.
- \* School Sport WA advertised the tournaments and sent a representative to help at each event.

#### **LiveLighter WA District High School Country Week**

- \* Badminton WA successfully managed the badminton component of this five-day School Sport WA event for the eleventh consecutive year. Ten schools sent 17 teams for badminton competition held at the Bendat Basketball Centre, Floreat. Badminton WA provided three coaches and 17 umpires to the week. Schools from Bridgetown, Champion Bay, Dalwallinu, Geraldton, Jurien Bay, Mukinbudin, Northcliffe, Pemberton, Wagin and Waroona competed in three divisions.
- \* BWF Shuttle Time and teaching resources were promoted to district high school teachers during the event. Teachers 'learn to play' sessions were conducted. A coaching clinic was attended by 80 players.

#### **Competition Results**

Winners: Div A: Jurien Bay DHS Team #1, Div B: Jurien Bay DHS Team #2, Div C: Jurien Bay DHS Team #3 Shuttle Time Wings Program

- \* The Wings Program has been successfully run for a fourth year. Ten Wings junior clubs operated in Perth throughout 2019 with more than 250 members training and playing weekly.
- \* More Wings players have attended mainstream Badminton WA sanctioned tournaments.

#### **Junior Tournament participation**

- \* Nearly every Badminton WA tournament has featured a junior division. Junior players from the Wings clubs, WA Under-15 High Performance squad, State team players, as well as participants from inter-state and overseas have entered and played in our tournaments.
- \* Many of WA juniors competed well both partnering and against the adult players.

#### **SPORTING SCHOOLS**

Sporting Schools is a federal government funded programme which provides primary and secondary schools with access to funds to use for group sports coaching. Badminton has been part of the programme since its inception in 2016. Programmes range in number from 4- 10 sessions, with students aged between 6-13 being introduced to the sport. Badminton WA provides all the required equipment.

In 2019 28 schools had badminton sessions for their students: Term 1: 5 schools approx 270 students Term 2: 4 schools (160), Term 3: 9 schools (490) Term 4:10 schools (475).

#### HIGH PERFORMANCE

The Badminton WA High Performance focus during 2019 was on the development of our Under-15 squad, which has now doubled in size from 2018.

With many juniors aged 13 and 14 coming through the ranks during the Under-15 trials, we were able to send two WA Teams, each comprising three boys and three girls, to compete in the Under-15 National Carnival. The results were promising as WA secured 2nd and 8th positions from a total of 11 teams.

The Under-15 High Performance squad increased to 32 players as we succeeded in discovering additional juniors with potential in Perth's northern suburbs. To accommodate this growth and provide quality training sessions, a north Under-15 High Performance group was formed with Nicholas Kidd appointed as coach. The increase has also created positive competitiveness among players in the entire High Performance squad. The south High Performance group continued to train under coach Yuli Zheng.

The progress made with High Performance squad has been largely due to the contribution of our two coaches and the Board of Management thanks and acknowledges them for their dedication, effort and time spent training and developing young badminton talents in Western Australia.

In 2019, WA continued to produce a number of junior badminton talents who were selected into Badminton Australia's 2019 National Junior Squads. Bernice Teoh was selected to represent Australia at the World Junior Championships, following in her brother Kai Chen's footsteps. Timothy Sentosa and Joanne Zheng were selected into the Under-15 Youth Development Squads.

Moving forward, we have finalized plans to grow our Under-17 and Under-19 groups (combined High Performance squad) to build the senior player foundations and provide a better training environment, in terms of personnel, equipment and strategies, to develop junior players.



#### COACHING

In 2019 the Coaching Development programme included:

- Provision of coaches for State Teams, High Performance squads, Sporting Schools sessions,
   Wings Clubs, groups & individuals.
- \* Managing one BA Level1 Coaching course
- \* Organising one Shuttle Time teachers course
- \* Facilitating a coaching forum providing coaches with Coach Development Activity points.
- Subsidising First Aid courses for coaches.
- \* Providing a direct link from the website to the Coaching Coordinator for all queries regarding the provision of coaches and courses etc

#### **BA LEVEL 1 COACHING COURSE**

Course was held on the 11th May

Six (6) candidates successfully achieved this qualification.

#### **BWF SHUTTLETIME COURSE**

Course was held on the 19th Oct

Four (4) successful candidates.

The Badminton WA Coaching Coordinator was appointed Chair of the Badminton Australia Coaching Advisory Committee. This national committee is revising the current coaching pathway.

#### **TECHNICAL OFFICIALS**

In 2019, members of the Court Officials Committee again provided their time and expertise to assist in the successful conduct of tournaments and events at which they officiated, within Western Australia. across Australia and internationally.

One of the biggest national competitions in Western Australia in 2019 was the successfully hosted BWF Future Series Perth International at Kingsway. The referees were Sandra David from Victoria and Lynne Nixey from New Zealand. With the organising committee and Perth-based umpires joined by three interstate umpires, the competition proceeded smoothly in and was well organised.

The conducting of interstate events, tournaments and other competitions has continued to enable our court officials to practise and enhance their skills at refereeing, umpiring or line judging.

With the Board's successful endeavours resulting in a continued increase in membership numbers for Badminton WA, prospective new umpires were attracted to attend an umpire's course, held in February. Bruce Napier held three line judge courses in 2019 in preparation for the Perth International, which required official umpires, service judges and line judges. WA also held a referee course in July for

up-and-coming referees. Most prospective umpires, line judges and referees successfully passed their entry level theory examination and have embarked upon obtaining practical experience before taking their practical examinations.

Congratulations to Jeff Tomlinson and Sachin Vishwanath for reaching Australian Accredited level in umpiring.

Our junior umpires continue to inspire with their great efforts at most of our local tournaments.



Thanks and appreciation go to Jiten Bhatt, Greg Vellacott, Lily Buttrose, Bradley Chen, Nicholas Nguyen, Eugene Glazman, Paul Garvey, Eva Wu, and Sachin Vishwanath who give of their time to either assessing, refereeing and/or umpiring at all tournaments held at Kingsway.

#### WA umpires at national carnivals

- June Bevan Trophy and Under 17 Australasian Junior Championships held in Adelaide, South Australia: Jenny Klein was the umpire for the Western Australian team at both events.
- C P Maddern Trophy and Under 19 Australian Closed Junior Championships held in Mandurah: Lily Buttrose and Eva Wu were umpires for the two Western Australian teams. Xiang Lin, Nigel Bonner and Grant Manzoney umpired for South Australia, Queensland and the Presidents team.
- Val Nesbitt Trophy and the Under-15 Australian Championships held in Calamvale, Queensland: Kim Rodgers was the umpire for the Badminton WA Wasps.



The Badminton WA policy of covering the travel and accommodation costs of State team umpires is a positive step towards encouraging interested persons to consider achieving a form of umpire qualification and then to utilise this to support the players, coaches and managers of State teams. The local tournament budget also continued in 2019 which allowed WA qualified umpires to gain great experience with some well-earned pocket money.

#### Representation at international events

Greg Vellacott in his capacity as BWF Umpire Assessor, attended the Celcom Axiata Malaysia Open to conduct appraisals and workshops, the annual BWF Umpire Assessor conference/workshop in Nanjing, China, Crown Australian Open to assess Australian and New Zealand national level umpires, Toyota Thailand Open to conduct appraisals and workshop, Danisa Denmark Open to assess continental certificated umpires from Asia, Europe, Oceania and Africa to BWF-accredited level.

Kelly Hoare in her capacity as BWF Certificated Umpire, umpired at the Crown Group Australian Open in Sydney, BLIBLI Indonesia Open, Japan Open, the BWF World Championships in Basel, Switzerland and HSBC BWF World Tour finals in Guangzhou, China. Kelly also assessed umpires at local tournaments at Kingsway.

Jiten Bhatt in his capacity as BWF Certificated Umpire, umpired at the Victor Oceania Championships and Victor Oceania Junior Championships in Melbourne, Yonex All England Open, Celcom Axiata Malaysia Open, Crown Group Australian Open, World Senior Championships in Katowice, Australian Junior International along with the duties at local events in Perth. Jiten won the 2018 WA Sports Star Official of the Year award, announced in early 2019. This is very well deserved, Jiten does a great deal for Badminton in WA, Australia and internationally. Well done Jiten.

Members of this Committee can be very proud of their contribution to our sport at all levels. Their contribution at a national and international level is especially significant and their essentially voluntary commitment to our sport is a tribute to the energy and enthusiasm they bring to the support of the sport at all levels.

#### **Committee matters**

Badminton WA Court Officials Committee: Kelly Hoare continues in the position of Chairperson for a term of two years from February 2018 expiring at the Badminton WA AGM in 2020. Jiten Bhatt continues in the position of Secretary for a term of two years from March 2019 expiring at the Badminton WA AGM in 2021.

Badminton Australia Court Officials Committee: Kelly Hoare continues as a member of this committee.

Badminton Oceania Technical Officials Committee: Greg Vellacott continues as a member of that committee.

As always, there is a need for younger officials to serve the sport. It is hoped that participants in the umpire's course held earlier in the year will continue to gain as much experience as possible and encourage other young friends and players to grasp the opportunity to umpire, referee and line judge wherever possible.





#### **PERTH INTERNATIONAL**



The 2019 Perth International caused a stir amongst the badminton community in WA. Sixty four international players, plus a similar number of interstate and local players took to the courts at the Kingsway Indoor Stadium for a BWF Future Series four-day event (5-8 September 2019) which was part of a three-event series with players moving from Perth on to Adelaide and then to Sydney.

Marquee player, Tan Boon Heong from Malaysia, credited with holding the Guinness record for hitting the shuttle the fastest (493 km/hr) and a former World #1, was a great attraction, with spectators keen to see him perform. He didn't let them down, winning the Men's Doubles title with partner Shia Chun Kang, an emerging young player, also from Malaysia. Tan showed great sportsmanship by staying around after the Final to meet fans and sign autographs as well as being a feature in many 'selfies'.

The event, however, was dominated by the contingent from Chinese Taipei. The women in particular, were strong competitors, winning both the Women's Singles and Women's Doubles titles, with their countrywomen also being the Runners-Up. They received strong support from the local Taiwanese community who welcomed the opportunity to see these high standard badminton players in action.

There were stand-out performances by local players Julian Lee and Hong Yuan Wong, who reached the semi-finals in the Men's Doubles, and WA young guns Dawson Lawrence and Timothy Sentosa, who gave the top-seeded pair, Sachin Dias and Buwaneka Goonethilleka from Sri Lanka a fright in a closely fought match that saw many long rallies and amazing retrievals and had the crowd providing great encouragement to this up and coming junior pair.

Support from the State and Local Government was warmly welcomed by Badminton WA and the presence at the Finals of Margaret Quirk MLA and City of Wanneroo Mayor, Tracey Roberts, plus Janet Lin from the Taiwanese Chamber of Commerce was acknowledged and appreciated.

With prize money of (US)\$9,999 the event was the stand-out feature on the Badminton WA 2019 tournament calendar, with the success, both in playing standard and spectator interest, boding well for future events of this level in Perth.

#### **CP MADDERN TROPHY: TEAM RESULTS**

Team matches were keenly contested throughout the event, with some very close results. The format was as per the Bylaws and the draw conducted by the Referee, with support from Eugene Glazman.

The Gold Medal match between NSW Thunder and Victoria Rebels was a hard fought match with NSW taking the title and WA Wasps winning the Bronze Medal. The Perpetual CP Maddern Trophy and Team medallions was presented by Stuart Rowlands, BA representative.

Milain Ranasinghe was Runner Up in the mixed doubles, Matthew Chew won the boy's Plate Gold Medal, Alicia Xu won the girl's singles Plate Gold Medal whilst Julian Lee and Hong Yuan Wong won the boy's doubles Plate Gold Medal.

#### **VENUE**


The Mandurah Aquatic and Recreation Centre (MARC) is centrally situated in the resort town of Mandurah, 100 kms south of Perth. The stadium has 16 permanent badminton courts and met all requirements for a national badminton event. Apart from the court area there was extra floor space for match desk facilities. The centre has a large aquatic area with several pools, kiosk, meeting rooms, and gym facilities. There was plenty of parking room for mini-buses and cars.



#### **FACILITIES**

As first reported in 2018 it was exciting to be able continue with staging of events at the Mandurah

Aquatic & Recreation Centre (MARC) in 2019. In July 2019 it was made the venue, the first time to host the CP Maddern U19 Teams Trophy national event followed by the U19 Australian Individual Championships. This was made possible thanks to the continuing generous support from the City of Mandurah and MAPTO, with facilitation from Sports Marketing Australia Pty Ltd.



It has been pleasing to note the addition of a privately operated facility of 6 courts in Balcatta, mid-year in 2019, namely the Nick Kidd Badminton Arena (NKBA). Badminton WA was able to utilise this new facility to host the Perth Graded Championships 2019 tournament event, when we had to separate and relocate the graded events away from as initially planned for concurrent running with the Perth International 2019 open event. Additionally, Badminton WA has now located its 'north of the river' High Performance Junior training programmes at this new and well equipped badminton specific facility.

Also as first reported in 2018, Badminton WA has continued to register and maintain its strong interest in two mooted 'south of river' sporting infrastructure project possibilities by local government, one possibility being in the City of Armadale and the other in the City of South Perth.

Otherwise, we look forward to continuation and growth of participation at our principal venue of Kingsway Indoor Sports Stadium, and at our regional members associations' leasehold badminton specific premises in Bunbury, Geraldton and the Eastern Goldfields in accordance with the overall Badminton WA strategic plan.



#### MARKETING AND COMMUNICATIONS

In 2019 our communications efforts focussed on four avenues: E-Newsletter, website, Facebook and YouTube.

Our "Badminton Shots" e-newsletter continues to be an important medium for a broad range of badminton-related updates, news pieces and event alerts, now delivered to more than 3500 subscribers.

One of our significant developments continued in 2019 with the live streaming service allowing for much better coverage of our tournaments on Badminton WA's YouTube channel. With integrated live score panel and graphics, we are now able to produce live video streams at quality level on par with some of the professional video companies at a fraction of a cost. Ability to incorporate additional graphics / logos / photo and video content opens new opportunities for collaboration with potential sponsors and event partners. Our website remains a source of information about our events and programs, and we find that an increasing number of people turn to it to find out about our affiliated clubs and associations, tournaments, coaching options etc. Our Facebook page remains popular (despite less than desirable update frequency), and has over 2000 followers. Utilising modern online tools and communication technologies allows us to be closer to our

members and the badminton community, although we are still very far from perfect.

Success of our programs and initiatives creates an excellent platform for partnering with a variety of businesses, building much needed ties and support networks. In the current economic climate this remains difficult, and our efforts are not always sufficient. We would like to ask our members who come from a variety of backgrounds and organisations to help us build a better future for badminton in WA.



#### TREASURER'S REPORT

I am pleased to be able to present to you in our Annual Report 2019 my "Treasurer's Report for 2019", with my recent 'casual appointment' Acting Treasurer capacity, following the elected Treasurer's resignation during 2019 (in early October 2019). Many thanks are due to Neal Miranda who had diligently been your elected Treasurer since March 2015, some 4.5 years of service in that capacity to Badminton WA.

The Board of Management considers the audited Financial Statements to be 'Special Purpose' financial statements prepared primarily for use of the Members of the Association in AGM, and them not to be 'General Purpose' financial statements for wider use or reliance upon by others, as is duly noted in the Auditor's Report following. However we endeavour to present the financial statements in compliance with relevant and appropriate Australian Accounting Standards Board pronouncements. We are only a Tier 2 entity for reporting purposes under our controlling Act of Parliament, not requiring audited financial statements by statute, but the membership has longstanding chosen to appoint a qualified professional Auditor, and also as stipulated in our Constitution/Rules document (in lieu of a Reviewer appointment of our prepared annual financial statements for AGM purposes).

#### **Operating Results (Income & Expenditure Statement)**

The Association has recorded a pleasing operating surplus of \$12,666 on an accruals basis for the 2019 year. Some key items which I want to comment upon are:

This was a busy year with two major events occurring in WA, the hosting of a BWF Future Series event from end September into October, the *Perth International* at Kingsway, and earlier the hosting of a junior event *National Carnival*, the U19s in Mandurah in July. We had anticipated that the U19s' event would show a small positive cash flow to us and had hoped budget wise to do some offsetting against an anticipated much larger deficit cash flow on the International event, especially after we resolved to increase the International event's prize monies from USD\$5k to US\$10k. The U19's event is in fact showing a job deficit of near \$400 contrary to expectations, and the International event a job surplus of A\$4.6k. No offsetting thus was in fact possible from the U19s' event. A lack of traditional grant support for this event, and having to rely on an interstate Referee appointment at additional (unbudgeted) expense and the Organising Committee local accommodation expense (also unbudgeted) extinguished the valuable saving with the MAPTO sponsorship able to be sourced of 'free venue hire' for the events hosting in Mandurah. The slightly larger job surplus result of the International event was only possible with the 11<sup>th</sup> hour support of a \$15k grant from the DLGSC for our event, for which we have to be very grateful for Life Member Judith Cousins' initiative in approaching MLA Margaret Quirk. The tremendous input of volunteer effort from the Organising Committee's members and other volunteers from the membership for these 2 events, belies the idea that we actually make a surplus out of hosting such events.

Elsewhere, we received a lower BA Participation Program grant than was budgeted; achieved significantly better than budgeted net income from our School Sport and Wings programmes; also achieving better than budgeted Tournament Net Income; and received marginally better than budgeted affiliations/registrations income; but finally less than budgeted bank interest income off our invested cash funds.

#### **Balance Sheet**

To possibly forestall any questions from members about the high level of Prepayments \$43,586 (2018 \$36,168), the simple explanation here is that the City of Wanneroo invoices us late in the year for our next year's bookings, and we process the invoice (including GST) as soon as received for our BAS position, but to note that we only have to pay monthly, as booked events occur. A similar explanation hopefully suffices for the absolute levels of Accounts Payable \$53,844 (2018 \$38,477) Revenue Received in Advance in the Current Liabilities section \$23,678 (2018 \$9,846) is principally related to 2020 Snr & U17 team nominations and fund raising/sponsorships. The Grant Received in Advance balance of \$5k is part deferment of BA Participation Grant monies, with programs not fully run/acquitted at balance date (extension of programs into Jan-Mar20).

#### Note 1: Summary of Significant Accounting Policies

The financial statements are prepared on the basis that The Badminton Association of Western Australia (Inc.) (the "Association") is a non-reporting entity. The financial report is therefore a special purpose financial report that has been prepared in order to meet the requirements of the Association's Constitution, Australian Accounting Standards and other authoritative pronouncements of the Australian Accounting Standards Board.

The financial report has been prepared in accordance with the following Australian Accounting Standards and Interpretations and the disclosure requirements:

- AASB 15, Leases
- . AASB 101, Presentation of Financial Statements
- AASB 108, Accounting Policies, Changes in Accounting Estimates and Errors
- AASB 1048, Interpretation of Standards
- AASB 1054, Australian Additional Disclosures.

The financial report covers The Badminton Association of Western Australia (Inc.) as an individual entity. The Badminton Association of Western Australia (Inc.) is incorporated in and domiciled in Western Australia under the Associations Incorporation Act 2015.

The financial report has been prepared on an accruals basis and on historic costs and does not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets.

The following is a summary of the significant accounting policies adopted by the Association in the preparation of the financial report. The accounting policies have been consistently applied unless otherwise stated.

#### Property, plant & equipment

The Association's fixed assets are office & other equipment and are brought to account at cost, less where applicable, any accumulated depreciation or amortisation.

The depreciable amount of all fixed assets is depreciated on a straight-line basis over their useful lives to the Association commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable asset are:

Class of Asset: Office equipment Other equipment
Depreciation rate: 20% 20%

#### Income tax

The Association is exempt from payment of income tax under Subdivision 50-A of the Income Tax Assessment Act 1997.

#### **Employee entitlements**

Provision is made for the liability for employee entitlements on the following basis:

- Annual leave statutory or contracted entitlement is provided for;
- Long service leave statutory or contracted entitlement is provided for;
   As at 31 December 2019, there was no liability for long service leave;
- Sick or other leave there are no sick or other leave entitlements that accrued as a monetary entitlement and therefore no provision has been established;
- Contributions required under the Superannuation Guarantee legislation are charged as expenses
  when incurred and remitted to the employees' nominated fund accounts as required by law.

#### Revenue

A number of the Association's programs are supported by grants received from the federal, state and local governments.

If conditions are attached to a grant, which must be satisfied before the Association is eligible to receive the contribution, recognition of the grant as revenue is deferred until those conditions are satisfied.

Revenue from the sales of goods is recognized upon the delivery of goods to customers.

Revenue from the rendering of a service is recognized when the amount of revenue can be measured reliably, collection is probable, the costs incurred or to be incurred can be measured reliably, and when the criteria for each of the Association's different activities have been met.

Interest revenue is recognized on a proportional basis taking into account the interest rates applicable to the financial assets.

All revenue is stated net of the amount of goods and services tax (GST).

#### Cash

For the purpose of the statement of cash flows, cash includes cash on hand and at call deposits with banks or financial institutions.
