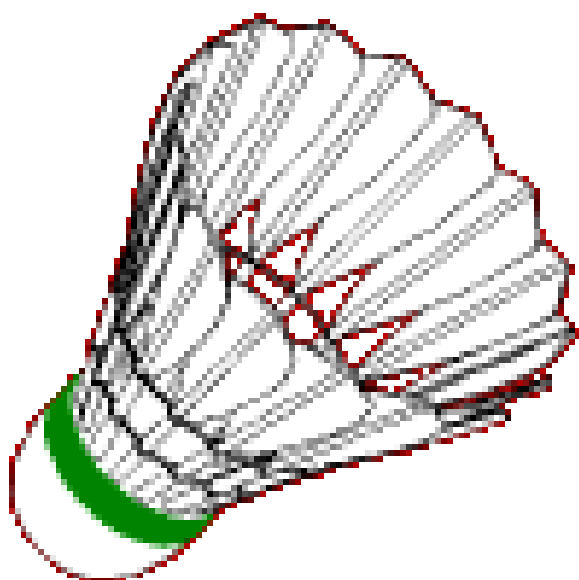

2017 WA UNDER 15 STATE TEAM

INFORMATION

Players nominating for State Teams MUST BE REGISTERED MEMBERS of Badminton WA.

Please read the following information prior to Nominating for this Team:

1. Event & Other Information

- i) This team will be playing in the **VAL NESBITT TROPHY** (Team Event), followed by the **AUSTRALIAN U15 JUNIOR CHAMPIONSHIPS** (Individual Event).
- ii) This Carnival (known as the **VAL NESBITT CARNIVAL**) will be held at the KINGSWAY INDOOR STADIUM
- iii) Venue: KINGSWAY INDOOR STADIUM, 130 Kingsway, Madeley WA 6065.
- iv) Date of Event: 24th -29th Sept, 2017.
- v) The selected Team will stay in accommodation only for the Team event from 23rd Sept till 27th Sept 2017.
- vi) A team of 3 boys and 3 girls is usually selected to represent WA. (The number of players selected for the team is solely at the discretion of the Badminton WA Board of Management and this is sometimes determined by player ability or team composition).
- v) The team will be supported by a Coach, Manager and Umpire. If necessary, a Chaperone will be appointed.

2. Badminton WA supports this team by:

- i) Paying the Team Entry Fee of \$612.
- ii) Paying the Coach \$1,000 for team training sessions prior to the departure of the Team.
- iii) Paying a minimum Honorarium of \$600 each to the Coach, Manager and Umpire for the event.
- iv) Subsidising accommodation for officials to the amount of \$440.
- v) Organising and paying for the Trials (court hire and shuttles)
- vi) Appointing Selectors
- vii) Providing supporting documentation for Local Council sporting grants for junior State players.
(These are for amounts between 100- \$400 depending on the Local Council.)

3. Nomination & Selection:

- i) By completing the nomination form and paying the appropriate fee, the Nominee is stating that he/she will take his/her place in the team if selected. Withdrawal from the team after nomination or selection may incur a financial penalty.
- ii) By withdrawing from the team after selection, the Nominee will not be eligible to play in the Individual Championship Event.
- iii) A player may not take part in any trial sessions unless:
 - a) He / she is a registered member of BAWA.
 - b) The Nomination Form is fully completed and accompanied by the required nomination fee.
- iv) The Nomination fee will be **\$150**. (\$30 is a non-refundable administration fee).
- v) Any player not selected as a member of the State Team will have \$120 refunded within 2 weeks of the team being announced.
- vi) Any player selected as a member of the State Team will have \$120 put towards his/her training expenses.
- vii) The Nomination fee of \$150 can be paid by Direct Deposit to the Badminton Association of Western Australia Inc account:

4. Training and trials

Attendance at trials and training is compulsory regardless of the time or venue.

Nominations close on 12th June 2017:

Trial times and Venue: Saturday 24th June 2017 1-4pm (Kingsway Indoor Stadium)
 Sunday 25th June 2017 1-4pm (Kingsway Indoor Stadium)

Team announced: By 3rd July 2017

Team training: Dates, times and venue to be advised following appointment of the Coach.

5. Competitions

All the players nominating for this team will be required to play in the:

- **State Junior Championships 13th & 14th July 2017**
- **WA Livellighter Silver Cup Tournament 19th & 20th August 2017**

6. Training costs:

\$120 of the Nomination fee will go towards Team Training fees for at least 8 sessions. Fees for additional training sessions may be paid, as required, to the Manager.

There will be no cost for the trials sessions.

7. ESTIMATED COSTS

This information is provided to give Parents a considered idea of the cost of this sporting trip.

As the 2017 Val Nesbit event is held in WA, there will be no cost for airfares.

However, the Manager will endeavour to obtain the most economical self- catering apartments suitable for the team. The suggested accommodation is the KINGSWAY TOURIST PARK.

The costs below are indicative and will be firmed up by as soon as quotes are available from each supplier.

- Accommodation: \$55 per night for 4 nights = \$220
- Food: \$ 35 per day x 4 days = \$140
- Entry fees for Individual Championships at Carnival—usually about \$90 for three events
- Functions: Usually about \$50 for two events
- Carnival Polo top: Usually about \$35 (not compulsory to buy)
- Carnival Team photo? Photo book: Usually about \$25 (not compulsory to buy)
- State Team Uniform – To be advised
- Spending money- at parent's discretion—minimum of \$50

BAWA subsidises the accommodation of the team officials. Each Team member contributes to the accommodation costs of the Team Officials if necessary.

TOTAL COST FOR THE EVENT WILL BE APPROXIMATELY \$525.

This does not take into account any fund raising and sponsorships.

Fundraising of \$1000 decreases the cost by \$100 per player, \$2000 by \$200 etc.

The Manager determines what kind of fund raising will be done. All fundraising ideas are to be presented to the Manager. All players are required to be involved with fund raising on request by the Manager.

8. PLAYER AGREEMENT

Once selected in the team each player must sign the player agreement - see attached.

Signing that agreement indicates that both the player and parent/guardian has read all the information in these notes and in the Player Agreement and agrees to ALL the conditions contained therein.

INFORMATION ON ROLES OF COACH, MANAGER, UMPIRE (AND PARENTS TRAVELLING TO SUPPORT THIS TEAM)

There are Badminton WA ByLaws covering the roles of the Coach and Manager.
See SUMMARY below.

The Coach and Manager work together to give each player the opportunity to reach their potential in a Team situation.

Role of the Coach:

Chair of Selectors for trials
Sets training times and venue
Controls and plans all training
Coaches all players during the Carnival
Chief Selector on tour

ALL ON-COURT MATTERS ARE DECIDED BY THE COACH

Role of the Manager:

ADMINISTRATIVE RESPONSIBILITY FOR THE TEAM

Collects training fees
Makes all arrangements
Keeps transparent financial records
Liaises with the Badminton WA Board
Oversees all team matters at the Carnival
Writes the final Report
Liaises with Coach/umpire/players/parents

ALL OFF-COURT MATTERS ARE DECIDED BY THE MANAGER

Role of the Umpire:

Umpires all Team Matches
Umpires when required at Individual Championships
Assists the Coach and Manager with Team matters when requested.
Acts as Chaperone when required

Any person (adult or child) representing Western Australia in a sporting activity such as badminton should be proud of the privilege and conduct themselves accordingly.

Being part of a sporting team –in any capacity- should be an enjoyable and memorable experience.

Role of parents:

- To support players during competition
- To support the Coach and Manager on request.

Parents must make their own travel arrangements.

- Accommodation
- Transport

Parents are strongly requested NOT to stay at the same accommodation venue as the players. The aim is to develop some self-reliance in these emerging young athletes. This is an opportunity for your child to become self-confident and be part of a team culture.

Assistance in tasks that help the team is valued **BUT** the Manager determines what will be done, how and when.

Following the selection of the team the Manager will speak with all parents to explain all arrangements and fund raising plans.

Badminton WA has **CODES OF CONDUCT** relating to Coaches, Officials and Parents/Guardians'

PARENT/GUARDIAN CODE OF CONDUCT

As a parent/guardian of a player participating in any activity held or under the auspices of Badminton WA a member association or affiliated club, you must meet the following requirements in regard to your conduct during any such activity or event.

1. *Respect the rights, dignity and worth of others.*
2. *Remember that your child participates in sport for their own enjoyment, not yours.*
3. *Focus on your child's efforts and performance rather than winning or losing.*
4. *Never ridicule or yell at your child and other children for making a mistake or losing a competition.*
5. *Show appreciation for good performance and skilful plays by all players (including opposition players).*
6. *Demonstrate a high degree of individual responsibility especially when dealing with or in the vicinity of persons under 18 years of age, as your words and actions are an example.*
7. *Respect official's decisions and teach children to do likewise.*
8. *Do not physically or verbally abuse or harass anyone associated with the sport) player, coach, umpire and so on).*
9. *Respect the rights, dignity and worth of every young person regardless of their gender, ability, cultural background or religion.*
10. *Be a positive role model.*
11. *Understand the repercussions if you breach, or are aware of any breaches of this code of conduct.*

STATE TEAM PLAYER AGREEMENT¹

I, _____ accept the offer to represent **The Badminton Association of Western Australia Inc. (BAWA)** at the **VAL NESBITT TROPHY & UNDER 15 AUSTRALIAN CHAMPIONSHIPS**, to be held in PERTH.

I have read and fully understand the terms and conditions set out below.

- I will represent Western Australia in a manner, both on and off the court that will bring credit to the Badminton Association of Western Australian Inc. and the sport of badminton in general.
- I will comply fully with all rules, regulations and decisions pertaining to team/player behaviour and team/player selection as set by the Board of Management, State Coach and Manager prior to, and during the National Carnival.
- I will attend all team training sessions as directed by the Coach and any other specific individual training sessions required by the Coach.
- I will participate in all competitions as specified by the Coach.
- I will participate in any fund-raising activities organised by the Manager.
- I will pay the appropriate training fees, when required, to the Manager.
- I will pay all costs associated with this tour, as and when directed, by and to the Manager. This is to include transport, accommodation and uniforms.
- I am available to participate under the direction of the State Coach and Manager in both the TEAM and INDIVIDUAL sections of the National Carnival.
- I will play as requested by the Coach in any of the disciplines in both the Team and Individual Championships.
- I understand there is no obligation by the Coach to play all players in the TEAM event of the National Carnival.
- I understand all players will be entered in the INDIVIDUAL championships.
- I will conform to the Australian Badminton Association's Drugs in Sport policy.
- I will ensure that all monies owing to BAWA are paid prior to my departure to the National Carnival.
- I will stay with the team, at my own expense (if necessary), at the designated accommodation venue for the whole period of the National Carnival.
- I will practice with the team, travel to and from the accommodation venue together, and eat together, as stipulated by the Coach and Manager, during both the TEAM and INDIVIDUAL championships.
- I will wear the designated BAWA uniform during all TEAM matches and whenever representing the State or team or whenever requested by the Team Manager. This uniform is to be purchased at my own cost if sponsorship is not available.
- I agree that I may be photographed during training, presentations or in team situations and these photos may be placed on a Badminton WA website, blog, or in publicity material for Badminton WA.

I understand that failure to meet any of the above conditions may result in my being removed from the team prior to or during the National Carnival. In the event on my removal from the team I may be required to face disciplinary action by the BAWA.
